#Fees After Govt. Subsidy are subject to individual family income. These are the out-of-pocket expense after the maximum CCS, hourly cap and 90% of CCS and 0% withholding.

The average CCS rate for families in the Alphington Grammar School Community is 54.3%.

Save on your OSHC fees with the Child Care Subsidy

Your family could save up to 90% on Outside School Hours Care (OSHC). This includes Rise then Shine (before school), Stay and Play (after school) and Holiday HQ (holidays programs).



You could be eligible if...

- Your **family earns under \$535,279** a year
- You **care for your child at least 2 nights per fortnight**
- You're **responsible for paying fees** at an approved service (all our services are approved by the Australian Government).
- You **meet Australian residency rules**
- Your **child must also be up to date with immunisations** (unless exempt) **and not in secondary school.**

The CCS amount depends on:

- Your **household income**
- Your (and your partner's) **work, study or volunteering hours**
- The **number of children in your care.**

The amount of subsidised childcare you can access per fortnight applies to each child.

To find out what your family might save, you can use the Child Care Subsidy Calculator at startingblocks.gov.au

The “3 Day Guarantee”

Good news! From 1 January 2026, all CCS eligible families will receive a minimum of 72 subsidised hours of childcare per fortnight, regardless of the family's hours of recognised activity.

For OSHC, this is approximately 6 days of Holiday HQ per fortnight and stretches even further for term-time sessions, Rise then Shine (before school) and Stay and Play (after school).

How to claim CCS

It takes around 30 minutes to apply. Here's how:

- 1 Create a **MyGov account** and **link it to Centrelink**
- 2 **Prove your identity** using documents like your **passport, license, or Medicare card**
- 3 Submit required documents — such as your **child's birth certificate and income information**
- 4 **Confirm your enrolment** in MyGov under Child Care > Enrolments

What happens next?

You'll receive an Assessment Notice through MyGov or by mail confirming:

- If you're eligible
- Your subsidy amount
- Any annual cap
- Any withholding amounts

If approved, your CCS will be automatically applied to your child care fees — no extra steps needed.
