

2027 FEE SCHEDULE Prep to Year 12

Fees and Charges are set by the School Board. Fees are reviewed annually and are subject to change from year to year. Fee Schedules are made available to current families and Applicants (who will be bound by its terms) in Term 3 each year for the subsequent year. Fee Schedules and The AGS Terms and Conditions of Enrolment are available on the School website. By keeping your child enrolled, you agree to follow these updated terms.

1. Application Fee: \$120 per student

This fee is **non-refundable** and paid at the time of each application.

2. Confirmation Fee: \$1,250 per student

Payable upon accepting an enrolment offer and returning the signed Enrolment Agreement. **Non-refundable and non-transferable**, valid for the applied year of entry only. This fee confirms a position in the nominated year level and will not be deducted from future tuition invoices or refunded if the student does not commence.

3. Terms of Payment

Edstart will work with each family to establish a payment schedule that is suitable. The options are full payment (attracts a 5% discount on tuition fees), termly (4 payments), monthly, fortnightly or weekly.

Upfront Full Fee Payment in Advance Discount: A 5% discount applies to the net tuition fee after sibling discounts have been applied when the annual cost of fees for 2027 is paid in full on or before 5 October 2026.

4. Due Date for Payments

Full payment of account via Edstart: **5 October 2026** (5% discount on tuition fees)

First Instalment date via Edstart: **5 October 2026** (Termly, monthly, fortnightly, weekly)

1. Year 7 students and any new Year 8 or 9 students are charged an additional one-off laptop fee to be paid with the first payment.
2. For Years 9 and 10, the fee covers the compulsory Gateways program. Additional charges apply for the elective Gateways option, e.g. participation in the European Gateways program, or other elective programs.
3. From 1 July 2025 onwards the Victorian Government Payroll Tax exemption no longer applies to AGS. This compulsory levy covers the estimated cost of this new tax for 2027.

6. Consolidated Fees and Levies (compulsory, non-refundable)

Consolidated Fee and Levies (compulsory charge) applicable to a particular year level are levied to cover the cost of compulsory programs that form part of the curriculum and includes online subject memberships and subscriptions, compulsory camps, excursions and incursions, sport fees, Inter-house and Inter-school competitions, subject competitions, art supplies, classroom music, provision of classroom texts, photocopying, the supply of printed materials, Student ID Cards, Student Diaries, homework folders, School Magazine and Student Accident Insurance Protection.

For years 9 and 10 it covers the cost of the Gateways program (excluding Europe).

The Consolidated Fee **excludes** private music tuition (refer point 10 below).

7. Tuition Fee Discounts

Sibling Discounts:

- 10 % discount on tuition fees for the second sibling
- 30% discount on tuition fees for the third and subsequent siblings.

Siblings receive a discount if they attend the School concurrently and no other discounts or fee assistance apply (e.g., bursaries or scholarships).

8. Building Fund Donation (tax-deductible)

The Building Fund Donation is a **voluntary tax-deductible** gift by each family to the school. We request a donation of \$1,500 per family per year. Funds received are used for new buildings and infrastructure along with repairs to existing facilities. This can be paid up-front or in installments via Edstart.

9. Scholarship Fund Donation (tax-deductible)

The Scholarship Fund Donation is a **voluntary tax-deductible** gift by each family to the school. Alphington Grammar School can open a world of opportunities. We offer a generous Scholarship Program for current and prospective students.

10. Additional Instrumental Music Lessons (optional)

These are **optional** classes for students. For further information please refer to the School Instrumental Music Program Policy. The rate for 32 individual music lessons is \$2,174 per annum. Lessons will be billed by Semester in two instalments. Semester 1 lessons are billed in Term 1 2027 and Semester 2 lessons are billed in Term 3 2027.

11. School Bus Run Services (optional)

The school's bus run services are managed by StudentRide. Full details can be found on our Transport Parent Portal at <https://studentride.com.au/alphington-grammar/>.

12. Payment of fees

Alphington Grammar School has partnered with Edstart to help families manage their fee payments. There is no charge to families for the service. Families are requested to sign up on the AGS/Edstart portal page <https://edstart.com.au/alphington>.

Note: students with outstanding fees may not participate in the European Gateways program or other elective programs.
